Parking Pass Application - Lake Parks Effective 02/26/2016**

Lake Summer Hours: (Memorial day - Labor day) 6:00 AM - 10:00 PM
Winter Hours: 7:00 AM – Sunset

- Anyone may purchase a parking pass allowing the bearer to park at **Willow Lake, Watson Lake and Goldwater Lake Park** as well as the **Peavine Trail/Sundog Ranch Road Trailhead**. The regular fee is \$3 at the kiosk. The fees for pre-purchased parking passes are as follows: **(Please select one)**
 - 10 park visits for \$20
 - 40 park visits for \$60
 - Annual Pass \$100- **limit one use per day**
 - **ALL PASSES EXPIRE ONE YEAR FROM DATE OF PURCHASE**
- Parking passes are good at any of the four sites where parking fees are collected. A printed receipt is valid at all of the four sites in a single day. The parking pass is valid for parking fees only – camping fees or special event fees are not included. All pass holders will abide by all park rules
- The annual parking pass does not guarantee admission to a park that has been closed, restricted, or reached capacity.
- To use this pass you will enter your 8-digit pin number into the kiosk. Your 8-digit pin **can** be your 7-digit phone number with a “9” in front of it (ex; if your phone number is 987-6544 your code would be 99876544), your driver’s license number minus the letter **or** a code of your choosing. To verify quantities left on your pass please call 928-777-1122
- To use the kiosk, press any of the buttons to start. When prompted “do you have an annual pass or reservation code?” select yes. Enter your 8-digit code. *Watch the screen for the number pressed to be replaced by the asterisk * sign on the screen* (especially important for codes with repeating numbers, such as 11, 22, 33, etc.). Once numbers are entered, press ok; a day-use receipt will print out.
- You will be responsible for displaying the day-use printed receipt on your dashboard. Failure to visibly display your day-use pass will result in a parking violation. Our Park Ranger Department will assume responsibility for enforcement, and parking citations will be issued to those vehicles that are not in compliance. It is therefore imperative that all parking pass holders understand that they must stop at the kiosk for a day-use printed receipt.
