

**RESOLUTION NO. 4327-1536**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PRESCOTT, YAVAPAI COUNTY, ARIZONA, ADOPTING CERTAIN REVISED AND NEW FEES FOR VARIOUS COMMUNITY DEVELOPMENT, PUBLIC WORKS AND WATER RESOURCES SERVICES.**

**RECITALS:**

WHEREAS, the Council of the City of Prescott ("City") adopted Resolution 4294-1503 on July 14, 2015, setting forth certain fees to be charged for Community Development, Public Works and Water Resources services; and

WHEREAS, the City wishes to revise certain fees and establish new fees; and

WHEREAS, adjustment of, and establishment of new Community Development, Public Works and Water Resources fees will reasonably recover City costs incurred for provision of services; and

WHEREAS, the revised and new Community Development, Public Works and Water Resources fees are in the best interest of the health, safety and welfare of the City.

**ENACTMENTS:**

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PRESCOTT AS FOLLOWS:

SECTION 1. THAT the City Council hereby rescinds Resolution Number 4294-1503 in its entirety.

SECTION 2. THAT the Mayor and staff are hereby authorized to sign this new Resolution 4327-1536, and take any and all action necessary to effectuate the terms contained in this Resolution.

SECTION 3. THAT the following fees will be charged for the following specified functions of the Community Development, Public Works and Water Resources:

2.	Re-inspection fees	\$50.50 per hour (Minimum charge, two hours)
3.	Inspections for which no fee is specifically indicated	\$50.50 per hour (Minimum charge, one-half hour)


SECTION 4. THAT said fees referenced in Section 3 of this Resolution shall be increased on July 1<sup>st</sup> of each year by an amount equal to the Consumer Price Index (CPI), unless a different rate is set by the City Council. The CPI, as used herein shall mean Consumer Price Index for all Urban Consumers (CPI-U) for the U.S. City Average for all items, as published by the Bureau of Labor Statistics, U.S. Department of Labor.

SECTION 5. This Resolution shall take effect and be in force on the 16<sup>th</sup> day of June 2016.
