This permit must be kept at the site of the explosive operation at all times and must be presented upon demand to any an all law enforcement officials or representatives of the City of Prescott upon request.

Issuance of this permit does not constitute an acknowledgement that the permit holder is in compliance with any City, County, State or Federal Laws or regulations and only constitutes compliance with City of Prescott Fire Department codes that apply regarding the installation, storage, handling, transportation or use of explosives. Issuance of this permit shall not be construed to be in lieu of any additional City, County, State or Federal laws, rules or regulations which may apply for the installation, storage, handling transportation or use of explosives.

The permitted hereby fully indemnifies, holds harmless and agrees to defend the City of Prescott, its agents, officers and employees from any and all claims, expenses, losses, liability, actions, suits or demands, including legal defense costs thereof, of whatever nature arising out of connected with this blasting permit.

I understand and agree to comply with all requirements set forth in the issuance of this permit. Any deviation will constitute a violation of this permit and may result in the cancellation of this permit.

The applicant hereby certifies that its use and possession of explosives, as applied for herein, is in compliance with all City, County, State and Federal laws, rules and regulations governing the same. Applicant further acknowledges that any violation of the permit to be issued hereunder, and any violation of any City, County, State, or Federal laws, rules or regulations governing the use, handling, or transports of explosives shall be sufficient cause for cancellation of the permit to be issued hereunder.
