Executive Summary

New private development submittals are slow and steady again this month. The following projects reflect significant investment in the City of Prescott and we thank these businesses for choosing to locate and expand in Prescott!

The new projects this month include prep work for a new phase of South Ranch in Deep Well Ranch (north Prescott, by Airport), two new Airport Hangar projects, a proposed Dignity Health YRMC Medical Campus in Deep Well Ranch off of Willow Creek Rd, another proposed Medical Campus off of Willow Creek Rd across from the Embry Riddle campus, Granite Dells Estates has submitted for a Master Plan Amendment for phases 7 and 8 which are the last remaining phases in that development, 2 new warehouse buildings in Centerpoint East, and the phase 2 of the Sterling Ridge development.

ANNOUNCEMENT: The City publishes updates to this list on a monthly basis. To continue providing this information consistently, the public can expect to see future updates on the last *Friday* of each month.
